Commissioner Jeff Reynolds called the meeting to order at 6:15 pm, via Zoom.

M/S/C/U (Guthrie/Aocba) The October meeting agenda was approved.

M/S/C/U (Acoba/Guthrie) The September 2021 meeting minutes were approved as written.

AUDITOR'S REPORT: Sheri McNeal

Vouchers were audited and certified by the Auditing Officer, as required by RCW 42.24.080, and those expense reimbursement claims certified as required by RCW 42.24.090 have been recorded on a listing, which has been made available to the Commissioners.

M/S/C/U (Guthrie/Acoba) Motion carried to approve the auditor's report (copy attached) and payment of warrants, numbering 6753 through 6762, in the amount of \$1,562.76 as submitted.

Credit card charges for the period ending 10/10/21 totaled \$230.48. The Commissioners reviewed the statement and backup documentation.

Jeff Reynolds reviewed the YTD financial statement. The Port income and expenses are on track for the year, and with October tax income we should come out with a surplus of income over expenses.

OLD BUSINESS

Maintenance Work Update: Acoba reported that Tikar Services is planning to do the parking lot restriping on the next dry day (after next Monday). The test pigeon doors have been built and will be installed at the same time.

IT Update: Jeff reported that the feed from the new security camera is not yet up on the website and he will follow up with David of Nerd Squad about that.

Redistricting: Jeff is still working on getting the numbers from the County.

Poster Board: Casey reported no progress on the poster board project.

Public Records Policy: Casey sent a copy of the Public Records Request Policy to the other Commissioners and the Secretary for review. Jeff said that the policy looks really good and just had a couple of small changes, which he emailed to Casey. Casey will look at those and modify the policy accordingly.
